#### 3.0 OPENING CEREMONY – MEETING OF THE BOARD IN PUBLIC – 7:00PM

President Nichols called the meeting of the Board in public to order at 7:15 pm.

#### 3.1 Pledge of Allegiance

Student Trustee Daniel Rico led the Board in the Pledge of Allegiance.

# 3.2 Welcome by Board President

Trustees Rhea De Hart, Sharon Gray, Dan Hankemeier, Carol Roberts, Evelyn Volpa, Willie Yahiro, and President Sandra Nichols were present.

#### 4.0 ACTION ON CLOSED SESSION

Trustee Gray moved to approve the employee agreement for one certificated employee, item 2.2.1. Trustee Hankemeier seconded the motion. The motion passed unanimously.

#### Action on Expulsions

Mary Ann Gomez, president, CSEA, commented that if the Board moved forward with approval of the agenda with item 13.3, the district would be in violation of contract agreement. She noted that the list of lay offs was not discussed with the bargaining units and therefore is non-compliant.

Trustee Gray moved to approve the agenda, removing item 13.6. Trustee Hankemeier seconded the motion. The motion passed unanimously.

Trustee Volpa moved to bring item 13.3 before 8.0. Trustee Hankemeier seconded the motion. The motion passed unanimously.

# 13.3 Report, discussion and possible action to approve Resolution # 03-04-07 to Layoff Particular Classified Employee Services. Report by Dorma Baker, Assistant Superintendent, Human Resources.

Dorma Baker reported that the item had briefly been discussed during closed session and asked Kathryn Benson to address questions or concerns.

Kathryn Benson reported that the resolution allows time for meetings required by contract. She added that legal counsel was sought to ensure legal procedure was followed when establishing the process for lay offs, which includes 16.5 positions. She noted that the list of layoffs was given to Bernie Murphy, CSEA's regional representative when it was completed, which was that same afternoon. Ms. Benson explained the necessity of the district to meet its financial obligations. She further clarified that there were documentations on the negotiations meetings and the discussions which took place. In addition, she noted that the District's attorney sits in on all negotiations meetings.

Dr. Mays also noted that the budget is such at this time that classrooms and programs would be inevitably affected.

#### Public comments:

<u>Mary Ann Gomez</u>, CSEA president, commented that on behalf of the unit she would be obtaining legal advise on the legality of the action being taken tonight.

<u>Judy Fuller, Angelita Lozada, Elsa Silva, Steven Martinez, Robin Butterworth, employees, spoke against the proposed list of layoffs.</u>

After a brief deliberating period and with the assurance that the resolution allowed for flexibility for further discussions on how CSEA and the District could avoid the proposed layoffs, Trustee Hankemeier moved to approve this item. Trustee Volpa seconded the motion. A roll call vote was taken and the motion passed unanimously.

#### 8.0 SUGGESTIONS, COMMENTS, AND CONCERNS

#### 8.1 Employee Organizations - PVFT, CSEA, PVAM and SCAST

PVFT – Carolyn Savino, president, spoke about the budget noting that there is very little left to cut without affecting the quality of education. She said that the first furlough day took place and that it had been successful. She added that the organization is discussing NCLB and the budget, noting that some schools are having trouble getting their textbooks.

CSEA – Mary Ann Gomez, president, spoke about the importance of the positions that are being cut and how they will affect the children of the district.

PVAM – Bob Rasmussen commented on the difficult times and the importance of continuing to work together.

#### 8.2 Student(s) Trustee Report

Danny Rico, Watsonville High School, gave the board an update on sports and of upcoming activities and events.

### **8.3** Governing Board Comments

Trustee Volpa commended staff for the work on furlough days and commented on her positive experience volunteering at one of the schools. She also commented on how impressed she was when she learned of a student who, in order to get to Aptos Jr. High when the bus couldn't get through, walked his way to school from San Andreas Camp.

Trustee DeHart commented on how Aptos High School's (AHS) principal is having a book club for parents and added on the importance of involving parents in the 25-book campaign. She commented on the work that Pajaro Valley Prevention and Student Assistance does with competitive grants, obtaining approximately 2 million in funds.

#### 8.4 President's Report

President Nichols congratulated Ana England of Lakeview for being a finalist to receive the presidential award for mathematics and science. She added that she would send a congratulatory letter on behalf of the board.

#### 8.5 Zone Administrators' Reports

Christine Amato-Quinn, Assistant Superintendent, North Zone, reported on the upcoming 75<sup>th</sup> anniversary of Valencia school, the planned celebrations that would start with the visit of Ray Cortines on October 13, and the receipt of the Community Enhancement Award from the Aptos Chamber. She added that AHS is planning its homecoming week and the game between AHS and WHS.

Ylda Nogueda, Assistant Superintendent, South Zone, announced the budget meeting that would include all three zones' site councils on October 15.

Dr. Nancy Bilicich, Assistant Superintendent, Alternative Education & Charter Schools, announced the kickoff event of the 1 Million Word (25 Books) campaign.

# 8.7 Superintendent's Report

Dr. Mays clarified that she is not having discussions with Kathleen Howard about the formation of a Mid-County district. She reported that there would be a county-wide superintendents meeting where the possibility of a parcel tax in the county would be discussed. She spoke of an article highlighting the importance of vocabulary on student achievement, and how the number of words each student is familiar with varies depending on their socio-economic level.

<u>Judy Fuller</u>, employee, spoke about the location of the District Offices in the towers and added that instead of leasing the office space the District should build a district office in one of the parcels it owns.

Robin Butterworth, employee, spoke about her position.

<u>Matsunami Iwao</u>, community member, requested additional information about the item on closed session dealing with the Pajaro Valley Water Management Agency.

# 10.3 Accept Schools Plus Teacher Classroom Grants Awarded to Eight Teachers at PVUSD, Total of \$4,713.

It was suggested that congratulatory notes to the teachers that have been selected should be sent and to send a thank you letter to Schools Plus, who has already awarded approximately \$148,000 to teachers of this district. President Nichols noted she would send those letters on behalf of the board.

Trustee Volpa moved to approve this item. Trustee Hankemeier seconded the motion. The motion passed unanimously.

#### 12.0 ITEMS FOR REPORT AND DISCUSSION

Due to the presence of administrators of Alternative and Charter schools at the meeting, the Board decided to listen to item 12.2 before item 12.1.

# 12.2 Report and discussion on Student Achievement in Charter Schook and Alternative Education. Report by Dr. Nancy Bilicich, Assistant Superintendent, Alternative Ed and Charter Schools.

Dr. Bilicich identified the schools involved in Alternative and Charter education: New School, Renaissance High, AVCI, Alianza Charter, Linscot Charter, Pacific Coast Charter, and Watsonville Charter School of the Arts. She read out their vision statement and reported on student data, assessment, learning environment, AYP status in English Language Arts and Mathematics, STAR tests results, and added that these programs and students are unique. She spoke about the improvement cycle which focuses on standards alignment, assessment and effective instruction with

the analysis of data and adjustment of plan. She commented on the importance of staff development, collaboration, program focus, community service, parent involvement, interventions and continued challenges for all students.

The Board participated in a brief discussion, asked questions and expressed their concerns.

Trustee Roberts moved to postpone item 12.1 for a future meeting due to the late hour. Trustee Gray seconded the motion. The motion passed unanimously.

13.4 Report, discussion and possible action to approve Job Description of Behavior Technician. First Reading. *Report by Dorma Baker, Assistant Superintendent, Human Resources*.

Kathryn Benson reported that she had worked with SELPA to develop this job description. She said that it was created as a result of IEP requirements when working with specific disorders, including autism. She added that there are some employees who would qualify for this position as well. She said that the salary would be Range 39.

Dorma Baker added that this position would eliminate having to outsource these services and save money.

Trustee Volpa moved to approve this item, requesting that the second reading include budget considerations. Trustee Gray seconded the motion.

#### Public comment:

<u>Mary Ann Gomez</u>, employee, commented that some employees, including herself, have this training and would qualify to fulfill its requirements.

The motion passed unanimously.

Trustee Gray moved to approve this item. Trustee Roberts seconded the motion. The motion passed unanimously.
