WHS Student Trustee Daniel Rico reported the seniors who have submitted applications to colleges have received replies. Scholarship applications are available for students to pick up. Basic skills tests were given yesterday during 4th period. Open House was held last evening in which progress reports were distributed. May 14th Prom bids are now on sale. Athletics have also been a major focus with the soccer team winning a title and the varsity cheerleading squad taking 2nd in the national championships and junior varsity taking 1st place.

AHS Student Trustee reported that sophomore testing will begin next week; ASB contributed to the 2nd Harvest Food Bank, a recognition breakfast for staff was held last week and the choir will hold a Rock 'N Soul Night.

Trustee Volpa commented that at least 20% of students who dropout are gifted and that the district is failing to meet their needs.

7.4 **President's Report**

Trustee Dehart reported that a Focus Walk will be held tomorrow at Starlight Elementary beginning at 8 am. The 2005 USA Spirit Nationals were held in Anaheim-Cheer 1st and 2nd place. On March 22nd, the City Council will hold a meeting at Mello Center with the high school involved in the meeting. Students need to see government in operation. Positive Program report today one of best Adult Education programs in the State and in the Nation. We reach out to the community.

7.6 Associate Superintendent's Report

Terry McHenry spoke on the Bond issues for North and South Zone. We can't do what's not listed. We are trying to do the whole list to meet the list. We will in fact build what we said we are going to build. Watsonville High School will have a weight room, an ASB office, an upgrade of the field science rooms and tennis courts. The Register-Pajaronian indicated that we were not doing this.

7.7 Superintendent's Report

Dr. Mays began by expressing the outrage she felt at what was happening in 184 of California's 309 districts that will possibly have to go under program improvement. It was

unfair of the state to notify the entire public of failing districts. It is not fair to public education or to children. Our board has been informed. The community should not believe that the district is failing.

8.0 POSITIVE PROGRAM REPORT – ADULT EDUCATION

8.1 Report and discussion on Adult Education

Report by Bob Harper, Director of Adult Education

Bob Harper, Director of Adult Education, gave an overview of programs and the amount of growth in attendance for Adult Education programs. There has been a loss of 12% in funding. Reserve funding is about half million dollars. Enrollment has gone down, but attendance has gone up due to learner persistence. The number of hours per enrollment continues to grow.

Adult Education is now located at both Cabrillo campuses as well the Porter Building. Mr. Harper mentioned that the Langedorf building downtown may be available for use as an ESL facility We have more than doubled our benchmarks with the help of Dr. Nancy Bilicich, Assistant Director. There are strong partnerships with the community. We have a global perspective as to how we serve the community.

Report by Ana Ventura Phares, Mayor of Watsonville

Mayor Ana Ventura Phares issued a Proclamation for Adult Education Week March 7-11. She also declared today as Adult Education Day The Proclamation was read and presented to Mr. Harper. She invited Mr. Harper and his staff to a City Council Meeting to give this report. It helps the entire community to know what is available in many careers such as health, which goes with our quality of life.

She mentioned that Councilmember Antonio Rivas had an idea of holding a City Council Meeting at the Mello Center later this month.

Report and discussion on School Attendance Awareness Month 13.1 Report by Ana Ventura Phares, Mayor of Watsonville

Ron Kinninger began by stating that March is School Attendance Month. Many teams are working together to help families keep kids in school. Mayor Ana Ventura Phares was at a community assembly featuring Caminos with 25-30 participants.

Mayor Ventura Phares presented a Proclamation declaring March as School Attendance Awareness Month. Sharing information is essential; communication with parents needs to continue.

The Management Audit put out some incentives to the schools. We compared attendance to last year at the same time. Schools that met or exceeded last year's attendance are presented with the Green banner which kids are proud to display.

13.3 **Report and discussion on Middle School Boundaries**

Reported by Terry McHenry, Associate Superintendent

Terry McHenry reviewed slides showing the new boundaries as indicated on maps. Dr. Mays commented that the expectation is to lower the size of our middle schools. Dan Hernandez thanked Terry and community members for the maps which seem to be a better feeder pattern. It helps with articulation and also fortifies the athletic program. This seems to be the best equitable plan seen so far.

Assistant Superintendent Catherine Hatch began by introducing Stuart Rosenstein, Chairman of the County LBTIQ Task Force, who will speak on the Safe Schools Resolution, AB537, the School Safety and Violence Prevention Act of 1999. By law, students and staff have the right to a safe learning environment in regards to gender, orientation, etc. Several students from AHS, WHS, PVHS, New School & Renaissance also were in attendance to support the resolution. Also speaking were Andrew Goldenkranz, who as Assistant Principal, daily gets referrals of students being taunted, and Lori Davenport, whose son had been harassed at school.

Trustee Volpa moved to approve this item. Trustee Keegan seconded the motion. The motion passed unanimously.

Report by Dr. Mary Anne Mays, Superintendent

Dr. Mays reported on that the final recommendation on the management audit report is inaccurate in regards to staffing in some departments. We are not top heavy, but we do need to look at Special Education, Migrant Education and one position in Human Resources. We have one of the lowest staffing in the area. In HR, the workload increased dramatically with the opening of 3 new schools. This year there will also be the new middle school to staff as well as PVHS who will increase enrollment with a new freshman class. At this time, it is not advisable to reduce staff in HR. Dr. Mays also recommends no change in the current zone structure. We are making great strides in student achievement and do not want any change to affect this.

Trustee Volpa moved to approve this item. Trustee Gray seconded the motion. The motion passed unanimously.

14.8 Report, discussion and possible action to Approve Process to Review Implementation of Management Audit Recommendations.

Report by Rhea DeHart, Board President, Sharon Gray, Trustee and Mary Anne Mays, Superintendent

Official procedure to implement recommendation of the Management Audit Recommendations suggests that four task forces be set up for the 4 areas of concern: classroom expenditures, human resources, media, and non-classroom management (maintenance). Committees will include CSEA, PVFT, district staff, parents, and community business/parent expertise.

Committees will report back on May 17th and May 25th for final findings and recommendations.
