8.1 Watsonville Charter School of the Arts.

Principal Trish Hucklebridge, former principal Sue Forson, and parents Leticia Preciado and Gilbert Moreno were present to speak about the school's mission and the many benefits it offers its students in academics using creativity in teaching academics.

Sheryl Gentry, music teacher, and her students performed for the Board.

8.2 Wetlands Education Resource Center Update.

Presentation by Catherine Hatch and WERC Staff.

Kris Beall, WERC member, thanked the Watsonville Wetlands Watch, the City of Watsonville and the Pajaro Valley High School for the collaborative partnership, which has benefited the city's environment by protecting its wetlands, and the school's students by enriching their curriculum. She presented a video which delineated the various ways in which the Center has been involved with the students.

Other Center members and some students were present to comment of the program.

13.0 REPORT, DISCUSSION AND POSSIBLE ACTION ITEMS

13.1 Report and discussion on H. A. Hyde's School Assistance Intervention Team (SAIT). Report by Catherine Hatch, Asst. Supt., Central Zone, and SAIT Rep. Vicki Alterwitz.

Vicki Alterwitz and Brett Knupfer, were present to give the sixth report on the progress of SAIT at HA Hyde. She stated that Hyde has progressed 44 points, meeting their goals in every category required by the state. All grades but one made significant increase in both math and language arts. Ms. Alterwitz stated that the SAIT's recommendations include the implementation of supplemental programs for assisting students that are far below basic in math or reading. Second recommendation is for the district to offer additional math support for teachers implementing the first year of math curriculum.

Mr. Knupfer stated that staff has focused on increased clarity in teacher presentation and student engagement.

Trustee De Rose moved to approve the SAIT report; trustee Keegan seconded the motion. The motion passed unanimously.

14.0 REPORT AND DISCUSSION ITEMS

14.1 Report and discussion on Adopt a School/School Partnerships. Report by Dr. Nancy Bilicich, Director of Adult Education.

Dr. Bilicich introduced Mr. Jerry Beyersdorff, president of the Pajaro Valley Chamber of Commerce. They gave a presentation outlining the program benefits for the schools, students, businesses, the community and all citizens. Artemisa Cortez, EA Hall School principal, commented on the school's involvement in the program and the generosity of the Rotary Club towards the school. Dr. Bilicich further commented on Adult Education's sponsorship by Tila Guerrero of McDonald's. Community members, Rhea DeHart and Sharon Gray, commented on Tila's contributions to the program.

14.2 Report and discussion on the English Language Master Plan Implementation Update. Report by Elena Fajardo, Director of EL Services.

Elena Fajardo, reported on demographic data for the English Learner subgroup and the plan's objective to meet the Annual Measureable Achievement Objectives (AMAO). She reported on the next steps for the plan's implementation, including all-staff training.

President Turley commented that California School Boards Association agreed to waive their annual conference registration fee for any trustee who wishes to attend. She enjoys hearing the positive program reports.
