8.0 POSITIVE PROGRAM REPORT

8.1 City of Watsonville Environmental Education Program.

Report by Tami Stolzenthaler, Environmental Education Coordinator

Tami began her presentation by stating that the program had provided over 30,000 field trip visits to the City's recycling center, water sources, wetlands trails, nature center, and the wastewater recycling plant in the last ten years. She mentioned that the intent of the program is to raise awareness of resource conservation in the City. The program is grade-specific from 4th through 6th grade. She mentioned that although there are budget challenges, the program is not in jeopardy of being cancelled due to the funding sources, which is part of the Public Works and Utilities Department fees.

Board President closed the regular Board meeting and opened the Public Hearing.

9.0 PUBLIC HEARING: LONG TERM FINANCIAL IMPACT OF THE TENTATIVE AGREEMENT FOR CERTIFICATED BARGAINING UNION EMPLOYEES (PAJARO VALLEY FEDERATION OF TEACHERS - PVFT) AS REQUIRED BY AB1200.

9.1 Report by Sandra Lepley, Interim CBO

Sandra reported that the law requires the District to make a public disclosure of the costs expected under the Tentative Agreement (TA) for the current and subsequent years. She noted that the Santa Cruz County Office of Education sent confirmation that the District would continue to maintain a positive Certification and that the TA better prepares the district for the 2012/3 year. The TA would save the district approximately \$1.3 million in 2010/11 and \$1.7 in 2011/12.

9.2 Public comment

<u>Christina Diaz</u> & <u>Sam Claypool</u>, students representing Education for the Future, advocated for the tentative agreement to try to keep counselors and teachers.

<u>Julie Vallens</u>, teacher, advocated for smaller class sizes with any savings from furlough days.

<u>Laura Zucker</u>, teacher, advocated for smaller class sizes in Kinder through 3rd. She read a letter from teachers recommending at most 25 to 1 with savings from the furlough days.

<u>Jack Carroll</u>, PVFT, asked the Board to approve the TA.

Martha P. Vasquez, teacher, spoke about the impact of the TA in the classroom.

<u>Bill Beecher</u>, community member, commented on the TA and recommended specific wording on some items to make it better for the District.

<u>Peter Nichols</u>, community member, spoke about student safety and the effect of the cigarette stores selling unsafe items, weapons to students. He also commented about the orchestra pit at Aptos High and the safety dangers it presents.

Dorma Baker commented about where the district is in reference to the orchestra pit, noting that it is in communication with the Department of State Architecture to remedy the situation.

Sandra Lepley noted that the district is 99.9% close to approval on the orchestra pit; she described the structure that will be covering it.

Dorma Baker asked for clarification as to why there is the impression that the preschool would close.

Dr. Nancy Bilicich, Director of Adult Education, commented that the pre-school depended on Adult Education funds and that there was a lot of uncertainty due to the funding reductions to the school; she mentioned that perhaps fees would need to be raised.

<u>Ann Veronica Coyle</u>, Adult Education teacher, spoke about comments from trustees that may have been misinterpreted to mean that the Adult Education School would be closing.

<u>Jack Carroll</u>, Adult Education teacher, asked for Adult Ed support from management.

11.0 EMPLOYEE ORGANIZATION COMMENTS – PVFT, CSEA, PVAM, CWAFrancisco Rodriguez, PVFT president, urging adopting a seal of biliteracy on the diplomas.

Michael Jones, PVAM, commented about the difficult budget situation and how programs are being affected.

14.0 REPORT AND DISCUSSION ITEMS

14.1 Report and discussion on Schools Identified by State for School Improvement Grants. Report by Dorma Baker, Superintendent.

Superintendent Baker reported that the California Department of Education and the State Board of Education were asked to established a list of persistently lowest-achieving schools, using a formula that included federal criteria (Academic Yearly Progress - AYP), state criteria (Academic Performance Index - API) and CAHSEE scores. A total of 188 schools were identified. This included 3 schools in Tier I, Calabasas, MacQuiddy, and Hall District, and 2 schools in Tier II, EA Hall and Watsonville High. The District will be applying for School Improvement Grants to assist the identified schools in Tier I in improving their scores. The State leaves it up to the District's discretion whether it will serve any or all of the Tier II schools. There are four models that the State has outlined to implement in identified schools: 1 – Restart Model, where schools close and reopen as charter schools; 2 – Turnaround Model, where the school replaces the principal and up to 50% of school staff; 3 – Transformation Model, schools replace the principal and increase instructional time; and 4 – Closure Model, where the school is closed and students are enrolled in other schools that are higher achieving.

It was noted that the District would consider only models 2 and 3. As next steps it was reported that administration would make initial visits to staff and parents of identified schools. Additional meetings would also be scheduled with principals of all Tier I schools. The District would submit grant applications sometime in June. In August, the school begins along with a model implementation.

Board participated with comments and questions.

Public comment:

<u>Bill Beecher</u>, community member, commented about Hispanic students and how they seem to score higher in the Northern area of the district. He also noted that there is a declining attendance of Hispanics in the District.

Dorma Baker commented that the State had taken funds retroactively from the extended learning program. This means that Extended Learning will not be able to fund summer school for grades kinder through 8th.

Ylda Nogueda stated that Migrant Education will be able to offer eligible students summer school and that the District would look at categorical funding to find out what options there are for summer school.

Trustee Yahiro noted that a fifth grade student from Radcliff took first place at the County Science Fair.

Trustee Osmundson reported that she attended the spaghetti dinner fundraiser to support the exchange program with Kawakami, Japan.

Trustee Keegan reported that he attended a meeting with the Centro Bi-Nacional (Bi-national Center) where there was discussion about opening an office in Watsonville for the indigenous people from Oaxaca. The meeting had many district representatives and the plan hopes to have the district involved somehow.
